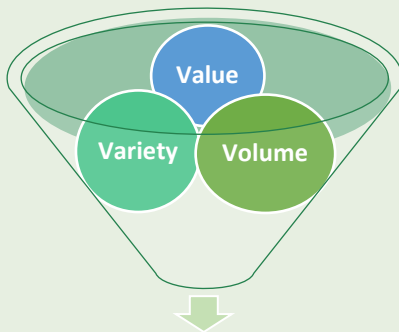

PRG holds a **100% stake in Phosphate Resources Limited (PRL)**, an unlisted public company which carries out phosphate mining on Christmas Island - an Australian Territory, located off the northern coast of Western Australia. **Christmas Island Phosphates** or known on Christmas Island as CIP, commenced its operations in 1990. It mines and processes rock phosphate on Christmas Island.

PRL owns 100% of a phosphate rock mine on Christmas Island and it exports approximately **600-700,000 tonnes per year** of phosphate product to a number of countries in the Asia-Pacific region.

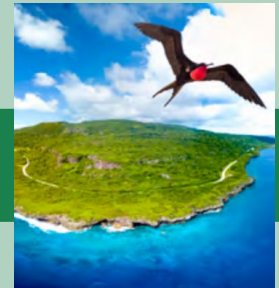
